The well-known Western sociologist E. Giddens sees the spiritual alienation of the individual in the context of globalization as a result of the economic phenomenon of society. However, it also emphasizes that the expropriation process takes the form of a legal formality. In both cases, the emergence of alienation in the economic or legal sphere is inevitable in society, but its real reason is inattention to the spiritual sphere.

In the philosophy of religion, the spiritual alienation of man is seen as the result of man's distance from direct communion with God. A person who has lost contact with the Creator loses his essence, including his spiritual essence. This, first of all, leads to various forms of alienation of man from man and becomes the cause and conditions of social violence. Frank, God destroys the alienation between "I" and "we" between the individual and society.
