In the middle of the 20th century, in the terminological context, theoretical discussions about the important features of the term began to gain special importance. It was created by the initiative of the Russian researcher and terminologist R. Piotrovsky, and the scientists who participated in this discussion, in turn, determined the further directions of the study of terminology. D. Lotte, G. Vinokur, A. Reformasky are the founders of the school of Russian terminology. Among the Western scientists who laid the foundation for the theory of terminology, first of all, the name of the Austrian scientist Eugene Wuster should be mentioned. The development and regulation of terms is different in different fields of science and depends on the development of a particular science. Since this development is continuous, the origin and order of new terms is also continuous. In general, careful processing and arrangement of terms in the native language is a necessary resource for creating textbooks and manuals, as well as for conducting classes in the native language. The lack of processing and disorganization of terms also affects the style of speech. Therefore, the regulation of terminology is a matter of great importance not only in the scientific field, but also in social life. Because the more important the development of science and technology is in life, the more important are the terms for its acquisition, management and development. From this point of view, the regulation of terms, its research from different aspects is of great scientific and social importance. It is a natural phenomenon that as a result of the rapid development of science and technology, with the appearance of new machines, devices, equipment and technological processes, new terms representing them are also emerging. however, the terminology of this field is constantly expanding. Another aspect of the matter is that the influence of countries that have developed over time and are increasing their position and influence in the international arena also contributes to this. Today, as physical education and sports are rapidly developing, improving the qualifications of the specialists who develop it, i.e. trainers, within the framework of modern requirements, remains one of the main issues in the development of the field. From this point of view, it is important to understand and understand the essence of terms and concepts in the training of physical education and sports specialists, as well as specific learning in their management. Today, in order to increase the position of the Uzbek language as a state language, the activities being carried out require in-depth research on terms related to physical education and sports.
